
2009-2010 AISD Parent Survey Casis Elementary School

Strong relationships among staff, students, and parents are critical to student success. In particular, parent involvement in education is associated with a high level of student achievement (for a meta-analysis see Fan & Chen, 2001). These survey results provide campuses with feedback about how parents feel about their treatment by school staff, and the school's educational environment, and how parents describe their child's education. The following report contains the results of the 2009-2010 Parent Survey for Austin Independent School District (AISD); longitudinal data are provided where applicable.

The image below displays factors that are known to be related to student academic growth. In this report, we focus on the role of parents (circled in red), which has been measured with six survey subscales: Respectful School Community; Information about Student Expectations and Progress; Academic Planning Information; Teacher Expectations; Support for Parental Involvement; and Parental Assistance, Communication and School Involvement. In Spring 2009, 129 parents returned surveys for Casis, representing 16% of students from Casis (compared to the district Elementary School response, 34%). Figure 1 represents the percentage of respondents with children at Casis from each ethnic group. The tables below show the total number of surveys Casis parents returned in 2009-2010, and the percentage of responses and students at Casis represented by each grade.




Figure 2. Parent Survey Subscales for Casis and all Elementary Schools, 2009-2010

Please note that some subscales have changed from previous years, making longitudinal comparisons inappropriate for some items and subscales. For items and subscales where longitudinal data are available, statistically meaningful changes are flagged with up or down arrows. Please share the results of this report with all campus staff and your Campus Advisory Council to inform campus improvement planning. The graph below depicts Casis's parent survey ratings over time, as well as parent survey ratings across all Elementary Schools in 2009-2010. Scores over 3.0 are desirable, as indicated by the red dashed line in the graph below. The first step in improving these characteristics is to examine the score for each area (Figure 2).

Casis's highest score on the 2009-2010 Parent Survey was Teacher Expectations. This measure was new to the 2009-2010 survey and is designed to measure expectations parents believe that teachers have for their children. Research shows that teacher expectations relate to academic achievement. We encourage your campus to continue fostering a positive learning environment with rigorous teacher expectations for all students.

Casis's lowest subscale score on the 2009-2010 Parent Survey was Academic Planning Information, which measures the adequacy of the information and assistance that parents receive from school staff regarding their child's academic future. Ask school staff to consider ways to involve parents in academic planning for their child.
