





Q18: How often have you experience type of bullying at your school?







Q20: How often does your teacher have to interclass to deal with student misbehavior?


Q10: During this school year, when you experienced any of the lowing types of bullying at school?






Q43: During this year, how often did you weer the Counter Medication (e.g., triple Cs, DXM, skittles, or Coricidin) to get high?




